



## Process for Follow-Up Student List Review in the PSO 2.0 App for School Districts

This document outlines the process for conducting the Follow-Up Student List Review by the District Administrator for the post-school outcomes (PSO) data collection. The Follow-Up Student List is assembled by ODE from three other data collections: Fall Membership, December Child Count, and June Exit collections.

### What is the purpose of the Follow-Up Student List Review?

1. To ensure your student list is accurate and ready for the Follow-Up Interview collection on June 1;
2. To confirm which students are eligible for the Follow-Up Interview; and
3. To allow time to make any necessary revisions to the list through the ODE Data Team.

### Who is responsible for reviewing and confirming accuracy of Follow-Up Student List?

- District Administrator
  - Completes the review or assigns a person/s to review the student list; and
  - Verifies the list as accurate and complete.

### When is the Follow-Up Student List available for review?

- April 15 to May 31

### Process for the Follow-Up Student List Review:

- Review the list of students in each school site.
- Mark students who are Not Eligible for the PSO Follow-Up Interview and the reason they are ineligible (i.e., returned to school, still in school, out of school for less than one year, or student is deceased).
- Contact the ODE Data Team ([ode.oss-datateam@ode.state.or.us](mailto:ode.oss-datateam@ode.state.or.us)) to add, revise, or remove students from your list. Only the ODE Data Team can amend the student list.
  - a. Email the SSID only (no student name) and the requested change to the ODE Data Team.
  - b. ODE will verify the requested change and update the PSO application. Please allow two weeks for this process.
  - c. District Administrator should review and verify any revisions for accuracy and completion.
- Once the list has been reviewed and verified, click the button: *Mark Review as Accurate & Complete*
